1. Call to Order: Chairman Knautz called the meeting to order at 1:31 pm.

- 4. Public Comments. None.
- 5. Approval of Meeting Minutes.
 - a. Chairman Knautz requested a motion to approve the Board of Trustees regular meeting minutes





of May 1, 2024. Trustee Leno motioned to approve, and Trustee Gola made a second. Without further discussion the motion passed unanimously on a voice vote with 10 ayes and 0 nays.

6. Consent Agenda – Financial Reports.

a. Chairman Knautz requested a motion to approve the NEDSRA Disbursements and Financial Statements as presented for the period ending April 30, 2024. Trustee Elsey made the motion, and Trustee McCann made the second. Chairman Knautz asked if there was any need for discussion. There being no further discussion, on a roll call vote, voting aye: Trustee Schmidt-Bensenville Park District; Trustee Hixenbaugh-Butterfield Park District; Trustee Harris-Itasca Park District; Trustee McCann-Lombard Park District; Trustee Muenz-Medinah Park District; Trustee Elsey-Oakbrook Terrace Park District; Trustee Kaspar-Village of Schiller Park; Trustee Gola-Village of Villa Park; Trustee Marquardt-Wood Dale Park District; Trustee Knautz-Village of Glendale Heights. Motion passed with 10 ayes and 0 nays.

7. Comments and Communications.

- a. Director Barton highlighted the Pool Party.
- b. Director Barton highlighted the Fiesta de Verano.
- c. Director Barton highlighted the Rise.

8. Agency Report.

Director Barton thanked the Lombard Park District for their help with converting the boardroom to a multi-purpose room and some landscaping in the front of the building.

Director Barton provided an update on the State Grant and advised that all the documents were submitted to the state and the state has confirmed receipt of all the needed documents.

Director Barton advised that the audit process started with Sikich and we are in the first stages of the process.

Superintendent Goode provided an update on Camp and advised camp will start the following week. Our camp programs were very popular, and some camps had waitlists that our team was working through. Our team also completed a site supervisor training that was attended by 38 attendees from our member partner's staff. Our first Flippin Into' Summer event took place last weekend and it was a great event and thanked the Lombard Park district for lending the griddles. On Friday, our coaches and 27 athletes will be leaving to ISU to compete in Summer Games.

Manager Marroquin advised that the Golf Classic is tentatively scheduled for Thursday, September 19th at Glendale Lakes. The track meet in May was a success and raised \$7700. He advised we received a donation of \$2200 from the Woman's Club of Addison and the funds will be used to install a magnetic wall in our sensory room.

9. <u>Unfinished Business</u>.

a. Director Barton provided an update to the building. Yesterday the work crews started the roof updates, and they are anticipating 7-8 weeks for completion. We have communicated to our

participants and families about the roof repairs and possible interruption in the parking lot and room changes. We are still working on bids for the elevator modernization and hope to have more information for the next board meeting.

- b. Director Barton reviewed the ADA Disbursement Extension and advised that Village of Glendale Heights and the Bensenville Park District have disbursement funds available to them and we have requested they request their funds by end of the year.
- c. Director Barton provided an update on the IGA with the Addison Park District. The draft of the IGA was distributed, and the draft was just received prior to the meeting and sent to the attorneys for review. Based on the review timeline the approvals will likely occur during the September board meeting.

10. New Business.

a. Healthy Minds Healthy Bodies

Jay Aguado provided an overview of the Healthy Minds Healthy Bodies program and the Summer Mobilization program that is kicking off on June 21st. The program will provide one free event at one of our member partner facilities and various weekly events and prizes for completion of those weekly events. He advised of several upcoming community events such as Lyric Opera House, participation in upcoming parades, coffee socials and Cubs games.

b. Financial Investments

Director Barton gave an update on the banking institutions currently used and has been working on finding alternative options that are better performing. He thanked the board for providing some suggestions that he is currently working on.

 - Director Barton has been working with other agencies and the member partners on the possible financial impacts of the upcoming FLSA changes.
- **11.** Other Business. Director Barton thanked the board and their staff for their participation in the various training and inclusion services that were offered. He also thanked the member partners for hosting our upcoming camps.

12. Chairman of the Board Comments.

Chairman Knautz advised he attended the Track Meet, the Prom and the Flipping Into' Summer events and thanked the NEDSRA staff for their hard work. He discussed the Rise event and suggested board members attend.

13. Board of Trustees Comments.

Trustee McCann congratulated NEDSRA on a great job on the Touch a Truck and the Flipping Into' Summer event. Trustee Hixenbaugh thanked the team for the various inclusion training and services as it provides them with huge help especially for their non-resident participants. Trustee Gola advised they are starting up a new Rec Center project and hopes to increase participation. Trustee Schmidt advised that they are working on a renovation to Sunset Park with the help of a grant. Also, Fisher

Farm will have some renovations, and the water park just completed a resurfacing. Trustee Muenz advised they have a new Assistant Superintendent of Parks and will be starting shortly. They are working on an OSLAD grant and hope to complete it soon. Trustee Harriss thanked NEDSRA staff for their help with the inclusion. She also provided an update on storage spaces for the upcoming camps. Trustee Elsey advised camp started on Monday. They will be having a Back to Nature event on Friday, and they are excited about the upcoming summer. Trustee Kasper advised that camp opens on Monday and the pool opens as well. They have hired two new employees that recently started and have one open position. Trustee Marquardt gave an update on a few bids opening for various parks and new fitness equipment bids.

Items to Note:

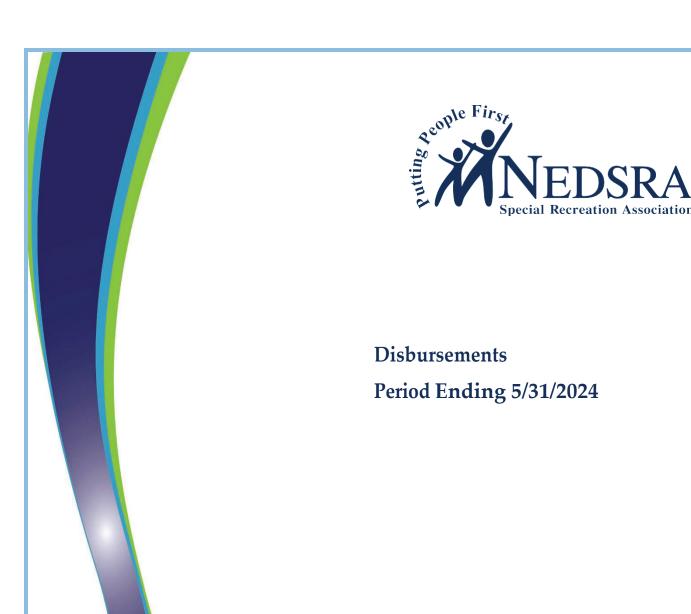
- The YTD Net Loss is \$23,374. This is due to the timing of partner contributions since invoices do not go out until June.

- We have received \$129,661 in program revenue, which is \$35,996 higher than the previous year at this time.
- Operating expenses are at \$160,598, which is in line with what we expected during the first month of the new fiscal year.

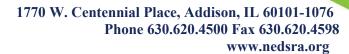

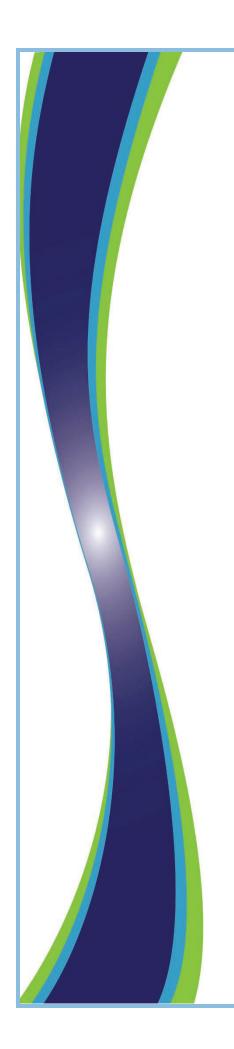

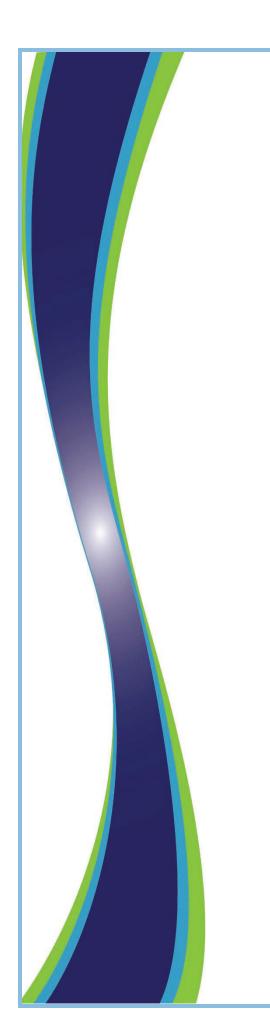

Re: Agency Report

Administration Report

NEDSRA received the State Grant check earlier this summer in the amount \$244,400, has submitted initial documents for this year's grant, and received the Notice of State Award for the \$75,000 grant. Staff are in contact with legislators regarding additional grant opportunities.

Director Barton attended the Oakbrook Terrace Park District's grand opening of Terrace View Park Playground on July 27. He was able to connect with Representative Blair-Sherlock who attended NEDSRA's Fiesta later that afternoon. Staff plan to attend the grand opening of Millennium Park in Glendale Heights on September 9.

Meetings and communications continue with several service providers, and potential service providers, in both banking and IT. Staff continue to seek clarification and information to determine the best course of action for NEDSRA.

Staff continue to monitor the roof replacement which is near completion. NEDSRA is awaiting billing and contingency clarification. Unrelated, one HVAC unit was found to be in need of repair earlier in the summer, and a second larger unit is experiencing a failure that has been difficult to diagnose. Flooring quotes are being reviewed and two elevator modernization quotes are also under review. Staff are working to obtain one additional quote for the elevator. The Larry statue at the main entrance was vandalized earlier this summer and repaired in August. A police report was filed.

Recreation

Summer Programs

As part of the initiative to increase cultural arts programming this year, NEDSRA participants from Dance Club, Karaoke and Showcase Choir performed group and solo numbers at Butterfield Park District's Glenbriar Park.

Five camps hosted in Member Partner facilities in Bensenville, Glendale Heights, Itasca, Lombard and at Addison District 4 ran for eight weeks. New this summer, a post-camp program included Swim Club and special trips. Weekly field trips, swimming and an all-camp event to Elk Grove Rotary Fest provided an action-packed schedule. The addition of Specialist Ross and a part time behavior interventionist aiding Coordinator Fritsch, resulted in a more successful summer for the participants and camp staff.

Seven NEDSRA participants and three staff enjoyed Glacier National Park in Montana August 12-17. The group stayed in an impressive log cabin near Whitefish Lake and experienced breathtaking views, a boat tour and local adventures.

Inclusion

Inclusion requests increased from the previous summer with eighty-nine unique individuals served. Requests were received from all eleven Member Partners. Support for summer inclusion began with spring's orientations and trainings with all Partners. NEDSRA site supervisors, inclusion aides, Manager Cline and Specialist Walderbach provided a successful summer for individuals throughout all Member Partners.

Outreach

NEDSRA staff and vehicles were involved at Member Partner events including Addison Park District's and Butterfield Park District's Touch a Truck. NEDSRA also participated in District 45's Schafer Elementary Back to School Night and DuPage County Veteran Resource Fair. Staff have committed to fall special events in Villa Park, Oakbrook Terrace and Itasca.

Fall Registration

Opening day was August 12 and set a record with six hundred and ninety registrations. Programs begin on September 8.

Marketing and Communications

NEDSRA has been contacted by several Knights of Colombus councils, looking for assistance with Tootsie Roll Days fundraisers and other events. NEDSRA staff will pick up shifts throughout the fall and NEDSRA will be a recipient of a portion of the funds raised.

The fall brochure was delivered to Partner facilities in August and first-day registration set a record. Production of the combined winter/spring brochure is under way and registration will open November 18.

Final preparations are under way for the Larry Roesch/NEDSRA Golf Classic taking place September 19. We are thankful for the Roesch's efforts securing donors and sponsors for the event.

Re: IGA with Addison Park District

Addison Park District went to bid for a roof replacement of the entire building at 1770 and 1776 West Centennial Place. This project includes replacement of NEDSRA's roof, the gym roof and installation of AC for the gym. NEDSRA has asked for the ability to pay for our portion of the roof over two fiscal years (2024-2025 and 2025-2026). NEDSRA's recently passed budget did include \$225,000 for the roof, with an additional \$225,000 anticipated for the following year. The total of \$450,000 includes \$91,200 for contingency. NEDSRA staff, working with NEDSRA's legal counsel, have an IGA that requires approval from both the NEDSRA and Addison Boards. Trustee Hermonson and Director Barton did discuss, review and revise this agreement during the past several months.

Recommended Motion to Approve the Inter-Governmental Agreement with Addison Park District:

I move to approve the proposed Intergovernmental Agreement with Addison Park District as presented, which includes details on NEDSRA's reimbursement plan for the roof replacement and installation of AC in the gym.

INTERGOVERNMENTAL AGREEMENT BETWEEN THE ADDISON PARK DISTRICT AND NEDSRA REGARDING ROOF AND HVAC REPLACEMENT

WHEREAS, the Addison Park District ("<u>Park District</u>") and the Northeast DuPage Special Recreation Association ("<u>NEDSRA</u>") (jointly "<u>Parties</u>") are units of local government under the provisions of the Illinois Park Code, 70 ILCS 1205/1, *et seq.*; and

WHEREAS, Article 7, Section 10 of the Illinois Constitution of 1971 and the Illinois Intergovernmental Cooperation Act 5 ILCS 220/1 et seq. allow units of public entities to enter into intergovernmental agreements in the furtherance of their governmental purposes; and

WHEREAS, the Park District owns and maintains a facility at 1776 W. Centennial Place, Addison, Illinois ("Centennial Park Facility"); and

WHEREAS, the Park District and NEDSRA entered into a Lease Agreement on November 27, 1989, for NEDSRA to use certain areas within the Centennial Park Facility; and

WHEREAS, the Centennial Park Facility is in need of a roof replacement and new HVAC System over the gymnasium (the "Project"); and

WHEREAS, the Park District and NEDSRA wish to enter into this Agreement to clarify the rights and responsibilities of the Parties with respect to the Project.

AGREEMENT

NOW THEREFORE, in consideration of the mutual promises of the Parties hereinafter contained and for other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. *Recitals Incorporated*. The above recitals are incorporated into and made part of this Agreement.
- 2. *Scope*. The Parties agree and acknowledge that the Project consists of the following items:
 - Roof Demolition
 - Roof Replacement
 - Skylight Replacement
 - Coping and Flashing Replacement
 - Roof Drains and Piping
 - HVAC Replacement Units
 - HVAC Screens
 - Raising Penetrations and Adjustments
 - Contingencies
- 3. **Project Management.** The Park District shall be responsible for all management of the Project including, but not limited to, bid awards, contract management, contract enforcement,

and any issues relating to guarantees or warranties of the Project work. The Park District is also responsible for any insurance for the contract and any liens arising from the contract.

4. *Costs and Payment.* The cost of the Project shall be divided between the Park District and NEDSRA as follows:

The Parties agree that the Park District is responsible for paying the contractor directly and that NEDSRA will reimburse the Park District over a two Fiscal Year period with the first payment due on or before September 18, 2024, and the second payment on or before June 1, 2025.

*If all or part of the "Contingency" payment is required from NEDSRA, the Park District agrees to provide records and receipts of the unbudgeted issues, repairs, and costs to be approved by NEDSRA's Executive Director or his designee before any reimbursement.

- 5. *No alternation to Lease Agreement*. The Parties agree that this Agreement is intended to delineate the cost-sharing responsibilities related to the Project and is not intended to change or alter any terms of the Lease Agreement. The provisions of said Lease Agreement remain in full force and affect.
- 6. *Indemnification*. To the fullest extent permitted by law, as it relates to this Project, each Party shall indemnify, defend and hold harmless the other Party, including their officers, officials, volunteers, employees and agents, from and against any and all liabilities, obligations, claims, damages, penalties, causes of action, costs and expenses, including reasonable attorney and paralegal fees, to which the indemnified Party may become obligated by reason of any accident, bodily injury, death of person or loss of or damage to tangible property, arising indirectly or directly in connection with or under, or as a result of the indemnifying Party's conduct and actions, except to the extent caused in whole or in part by the negligent or wrongful acts of the indemnified Party, its officers, officials, volunteers, employees and/or agents.

- 7. *Insurance*. The Park District will ensure that the Contractor(s) for the Project name NESDRA as a non-contributory additional insured to the same extent as the Park District and will provide certificates of insurance upon request.
- 8. *Enforcement*. The failure of either Party to insist upon the performance of any of its terms and conditions, or the waiver of any breach of any of the terms and conditions of this Agreement, shall not be construed as thereafter waiving any such terms and conditions, which shall continue and remain in full force and effect as if no forbearance or waiver had occurred.
